## PHOTOGRAPHY RELEASE FORM – “SAVE THE CHERUBS” CDH AWARENESS CAMPAIGN

1. CHERUBS shall have the right to use your photograph(s), consisting of models supplied by CHERUBS for the “Save the Cherubs” Congenital Diaphragmatic Hernia Awareness Campaign.
2. You grant CHERUBS the exclusive right to reproduce and reprint the photograph(s) taken during the CDH Campaign Awareness photo shoot, for the purpose of publication, promotion, illustration, advertising, or trade, in any manner and/or medium relating to the CHERUBS’ CDH Awareness Campaign.
3. You will retain ownership and copyright of your work and all other rights not specified herein.
4. You will supply CHERUBS no less than 10 photographs taken of our models within 15 days of photo shoots.
5. You will agree to create exchange links to and from your web site and our web site located at <http://www.savethecherubs.org> for a minimum of 1 year.
6. You admit that you are older than 18 years of age, have no criminal record and know of no reason that you should not be permitted to work with children.
7. You agree to print, autograph and mail one of the said photographs to be used by CHERUBS as an auction item for fundraising purposes. You agree to mail such photograph to CHERUBS within 30 days of the photo shoot. You waive all rights to any funds CHERUBS main obtain from the sale of said photograph.

8. You agree to give CHERUBS exclusive rights to use photographs of our models for fundraising purposes through the sale of products with the likeness of your photographs. You waive all rights to any funds CHERUBS may obtain from the sale of said products.
9. CHERUBS agrees to heretofore never use your photographs without giving appropriate credit to you, the photographer.
10. This agreement is executed as of the date of signature, below.
11. You represent and warrant that you are the sole author and owner of all rights in and to the photographs and that the photographs are original and do not infringe upon any statutory copyright or any common law right or proprietary right of any individual or organization.
